#### **Article 1: Purpose**

#### 4.4 Nonexclusive discussions

The parties acknowledge and agree that the areas of collaboration under this MoU are being undertaken on non exclusive basis and either party shall be free to enter into or consummate transaction similar to the areas of collaborations with other parties or elsewhere

#### 4.5 Licensee and intellectual property rights

4.5.1 No license is granted under this MoU to either party under any of other party's intellectual property rights, either expressly ,by implication, inducement, estoppels or otherwise. Both parties understand and acknowledge that grant of any such license shall always be express and in writing




