Both Parties are willing to extend USG facility to the patient of Dr. Rajendra Gode Ayurved College Hospital And Research Center, Amravati on the agreed terms and condition

Article 1 EFFECTIVE DATE

- 1.1 The Parties hereby agree that the Effective date of the agreement shall be the date on which the agreement is signed
- 1.2 The Agreement will be valid for a period of 05 years from the effective date of agreement.

Article 2 : DUTIES OF SERVICE PROVIDER

- 2.1 : The receptor must be aware that provider is giving his services for social cause
- 2.2 : The receptor will extend priority to the beneficiaries
- 2.3 : The Receptor shall ensure that best medical treatment / facility is extended to the beneficiary.
- 2.4: The receptor will instruct their attending consultant to advice investigation with prior appointment of provider as per his convenience.
- 2.5 : The receptor must give complete information about fees and other expenditure to the beneficiaries.
- 2.6: The receptor shall ensure the convenience of the provider at best

Article 3: DUTIES OF SERVICE RECEPTORS

- 3.1: The Provider shall treat beneficiaries in a courteous manner and with good clinical practices.
- 3.2 : The provider will extend priority to the beneficiaries.
- 3.3: The provider will convey the reports to the consultant
- 3.4 : The provider will convey the reports to the consultants
- 3.5: The provider will instruct their attending consultant to keep the beneficiaries only for the required number of day of treatment and carry out only the required by patient for his benefit, are not payable by institute and the constant will have to inform the patient that he will have to bear the cost of the same

Article 4: PAYMENTS FEES – TERMS & CONDITIONS

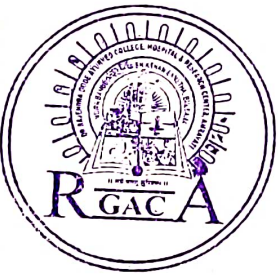
4.1 Beneficiaries should have to pay requisite fees of the service provider, except economically backward patient with the permission of signature authority.
